

FORMAL ACTION REPORT

Please find below a summary of actions taken or initiated by the Ohio State Dental Board in February 2001.

1. CITATIONS/PROPOSED DENIALS

OH, Sam. (30021182)– Toledo

Based on the doctor's alleged failures to comply with the infection control rules and permitting unlicensed radiographer to take radiographs, Notice of Opportunity for Hearing mailed February 15, 2001.

ZAK, John F. (30020816) - Canton

Based on the doctor's alleged permitting an unlicensed operator and misrepresentation, Notice of Opportunity for Hearing mailed February 15, 2001.

2. FINAL ADJUDICATION ORDERS

GIBSON, Reginald A. (30015015) - Cincinnati

Dental license is revoked, based on the Board finding counts 1 and 2 of the Notice of Opportunity for Hearing to be true, involving violations of Consent Agreement. Agreement sent February 16, 2001, effective immediately upon receipt.

3. CONSENT AGREEMENTS

GOLUB, Jerome N. (30012464) - Cleveland

Dental license suspended for 60 days beginning April 1, 2001; shall complete 20 hours of continuing education in dental ethics within 3 months, shall take and pass the jurisprudence examination within 60 days; upon reinstatement, license shall be subject to probationary conditions for 3 years, submit quarterly declarations of compliance. Agreement effective February 15, 2001.

POOLE, Dwight K. (30013745) – Belpre

Doctor shall cease and permanently desist from rendering any form of orthodontic treatment, effective June 1, 2001, shall immediately

refer all current and future patients to other practitioner(s) for orthodontic treatment, except those patients whose orthodontic treatment will be completed by June 1, 2001; dental license suspended for 30 days, effective June 1, 2001, shall obtain 20 hours of continuing education in dental ethics and treatment planning within 3 months, shall take and pass the jurisprudence exam within 1 month; once reinstated, license shall be subject to probationary terms for 2 years; submit quarterly declarations of compliance. Agreement effective February 16, 2001.

SANTUCCI, A. Scott (30018923) – Niles

Dental license suspended indefinitely until such time as reinstated by the Board; prior to reinstatement, Board shall review documentation submitted from doctor to determine if doctor is physically/mentally able to return to practice. Upon reinstatement, license shall be subject to probationary terms, conditions and limitations for a period of 5 years. Agreement effective February 16, 2001.

4. **ORDERS OF DISMISSAL**

BLAKESLEE, Kimberly C. (30020725) – Waterford, MI

Based on recommendation of Board Secretary charges are dismissed. Effective February 14, 2001.

HANNAH, George M. (30015757) – Plano, TX

Based on recommendation of Board Secretary charges are dismissed. Effective February 14, 2001.
