Please find below a summary of actions taken or initiated by the Ohio State Dental Board in January 2006.

CITATIONS/PROPOSED DENIALS:

DEVAULT, TRACIE, D.D.S. (30021370) – REYNOLDSBURG

Based on the doctor's alleged failure to meet the standard of care. Notice of Opportunity for Hearing mailed January 9, 2006.

FRANKEL, MERLE A., D.D.S. (30011799) - LYNDBURST

Based on the doctor's alleged failure to comply with the infection control rules. Notice of Opportunity for Hearing mailed January 9, 2006.

REIFENBERGER, DAVID E., D.D.S. (30015326) – LIMA

Based on the doctor's alleged failure to meet the standard of care. Notice of Opportunity for Hearing mailed January 9, 2006.

FINAL ADJUDICATION ORDERS:

CONSTANTINESCU, VICTORIA, D.D.S., (30017128) – CLEVELAND

Doctor's dental license is suspended for a period of thirty (30) days. Doctor shall take seven (7) hours of continuing education in infection control and submit a written request for reinstatement. Doctor shall be subject to a probationary term of one (1) year. Doctor shall (A) submit quarterly declarations under penalty of Board discipline stating that she is in compliance with the terms of this Order; (B) obey all federal, state and local laws, and all rules governing the practice of dentistry in Ohio, (C) submit to the Board, on a quarterly basis, documentation from an independent testing agency indicating that the heat sterilizing devices in her office are tested for proper function on a weekly basis by means of a biological monitoring system that indicates microorganism kill and that immediate remedial action was taken if any biological spore test was positive, and (D) fully cooperate in the Board's inspections and/or evaluations of her dental office, which shall occur as often as the Board deems necessary to ensure compliance with the Dental Practice Act, Chapter 4715 of the Ohio

Revised Code. Order shall become effective thirty (30) days from the date of mailing of the Order. The Order was mail January 17, 2006.

CONSENT AGREEMENTS:

HAAS, DAVID G., D.D.S. (3012470) - AKRON

Doctor's license to practice dentistry in the State of Ohio shall be **SUSPENDED** for a period of thirty (30) days beginning on January 17, 2006. Doctor shall complete eight (8) hours of continuing education pre-approved by the Secretary of the BOARD in dental infection control. Doctor shall be subject to the following probationary terms, conditions and limitations for a period of one (1) year: a. doctor shall fully cooperate with the BOARD investigators in future inspections and evaluations in accordance with law and shall make any or all of his patient records available for inspection and review and b. shall obey all federal, state and local laws, and all rules governing the practice of dentistry in Ohio.

Agreed Order of Censure. Doctor is censured for violating Ohio Administrative Code Sections 4715-5-04(D) and 4715-13-04. Doctor is ordered to maintain compliance with all sections of Chapter 4715 of the Ohio Revised Code and the Rules promulgated thereunder, in particular, Ohio Administrative Code Sections 4715-5-04(D) and 4715-13-04.
